Covid : Masks covering nose and mouth must be worn at all times on and around the venue, except when skiers are taking their race run. Racers can remove mask when entering the start, and must put their mask back on before exiting the finish. Masks must also be worn in lift lines. Coaches must conduct daily symptom checks of their athletes prior to inspection. This may be a verbal acknowledgement that the athlete has no symptoms that could be associated with COVID-19. If an athlete, does have symptoms at any time during the event, remove them from the ski area and contact Jon Nolting or a jury member. Boys must stay out of the fenced start area during the girls' race- girls must stay out of the start area during the boys' race. No spectators are allowed at the finish. This includes athletes congregating after their run. Following their race run, athletes must leave the finish area. If coaches, parents or teammates are bringing gear down for racers, take it to the base of Christie III. No spectating or congregating in the Tack Shed/Short Cut Road area. Parents are not permitted within the race arena, including fenced areas around the start. Only credentialed coaches, athletes, officials and volunteers are allowed on the venue.
